3) I acknowledge that USEF's Safe Sport Policy and Minor Athlete Abuse Prevention Policies are intended to protect athletes from abuse and risks of harm in sport, and that unrelated adults are not permitted to ride in a vehicle alone, to engage in activities that are not observable nor interruptible by another adult, to interact one on one, or to share lodging with an unrelated minor athlete, absent emergency circumstances, and must have at least two minor athletes or another adult at all times, unless I provide my express written consent in advance of the participation, travel, and lodging;

4) I understand that IEA and USEF recommend that I watch the Parents Guide to Misconduct in Sport, provided at no cost to me and produced by the U.S. Center for SafeSport before providing this consent, which can be found at <https://athletesafety.org/>;

5) I authorize and consent to the release and disclosure of this consent form, Minor Athlete's name, travel details, and other relevant information, as needed, to demonstrate my consent of Minor Athlete's participation, travel, and lodging.

I certify that I am 18 years of age or older and the legal guardian of the Minor Athlete. In addition, I certify that I have read, fully understand, and agree to the terms of this informed consent, and I sign it voluntarily with the full knowledge of its significance. If I am signing and submitting this Agreement electronically, I acknowledge that my electronic signature shall have the same validity, force and effect as if I affixed my signature by my own hand.
